**A permit will not be required for any accessory building of 100 square foot or less.**  
**Post construction fee will be due if building is started, including excavation, before a permit is obtained.**

**Special Use Permit (SUP/ Planned Unit Development (PUD) / Subdivision:**

SUP Modification	\$350.00 + additional fees for professional services and postage, if required
STR	\$700.00 For initial permit and \$400.00 Renewal
PUD/Subdiv Sketch Plan	\$300.00 + additional fees for professional services and postage, if required
Preliminary Plan	\$700.00 + additional fees for professional services and postage, if required
Final Plan	\$700.00 + additional fees for professional services and postage, if required
Modification	\$400.00 + additional fees for professional services and postage, if required

Prior to recording of final plat, the applicant shall deposit with the County Commissioners, one thousand dollars (\$1000.00) per dwelling or commercial unit. The fee is to be divided as follows: Twenty percent (20%) to County General Fund, Thirty percent (30%) to County Capital Improvement Fund, Twenty percent (20%) to Road and Bridge Department, Ten percent (10%) for the Sheriff's Department, Ten percent (10%) to the C-1 School District, and Ten percent (10%) to Emergency Services.

County Subdivision Road Access Permit: \$275.00

Applicants may be required to pay postage

**Misrepresentation of an application will cause a permit to be cancelled and will require a new application and fee.**
